



## EMN EVENT Presentation of the study on the integration of applicants for international protection in the labour market – limitations, challenges and best practices.

30 October 2023, 11:00 - 12:30 CET Online

## **1. RATIONALE AND AIMS**

Over the period from 2017 to 2022, there were over three million applications for international protection in the EU, with the highest number recorded in 2022. The majority of these applicants fell within the working-age category, which suggests a potential labour force that could contribute to the job markets of European Migration Network (EMN) Member Countries. The integration of the applications for international protection into the labour market is a vital aspect of migrant integration and their successful engagement in society. This importance stems not only from its role in providing economic independence but also because it significantly impacts the health and overall well-being of migrants in the EMN Member Countries. In addition, European businesses are facing significant challenges concerning labour and skill shortages, thus potentially leading to an increased reliance on individuals from third countries to address the projected shortages.

The EMN is hosting an event with the aim of promoting a <u>study on the integration of</u> <u>international protection applicants into the labour market</u>. This study provides a thorough and up-to-date examination of the legislation, policies and practices pertaining to this area within the EU. It also presents an overview of the various stakeholders responsible for implementing labour market accessibility, emphasising both the challenges encountered and examples of good practices.

The event's objective is to clarify the legal framework and mechanisms governing employment opportunities for international protection applicants, specifically emphasising the Reception Conditions Directive (2013/33/EU), and how it varies when integrated into the national laws of different EMN Member States. One of the most debated issues in this context is the waiting period for applicants. Discussions have revolved around two key perspectives: one advocates shortening the waiting period to speed up access, and the other advocates extending it to prevent potential abuse of the asylum system through excessively facilitated access. Additionally, the event will address the limitations set by EMN Member States and the difficulties encountered by international protection applicants, including issues like language barriers and intricate administrative procedures.

In conclusion, the event will also spotlight effective strategies for incorporating international protection applicants into the labour market and best practices.
